If for any reason any provision of this release is determined to be invalid, the remainder shall continue in full force and effect. If I am being furnished an equine, I acknowledge reasonable and prudent efforts have been made to determine my ability to safely ride, train, drive, groom, or ride as a passenger upon an equine and to manage the equine furnished. If I am being furnished equipment or tack, I acknowledge it has reasonable and prudently been inspected. This release contains the entire agreement between the parties here to and the terms of this release are contractual, not a mere recital. Equine Law is applicable pursuant to ORS § 30.687 (1993).
